1. What should I have available for the speaker on stage?

Cory may utilize a whiteboard and dry erase markers for his presentations, podium and a bottle of water. A lapel microphone is preferred over a handheld microphone. It is also helpful to have a volunteer to assist with the resource table outside the conference room.

2. How should I introduce the speaker?
